

FREE PROPRIETARY LICENSE AGREEMENT FOR CodeSynthesis XSD SOFTWARE.

This Free Proprietary License Agreement for CodeSynthesis XSD Software ("License") is a legal agreement between you, the Licensee, (either an individual or a single entity) and Code Synthesis Tools CC for employing the SOFTWARE and for distributing the SOFTWARE, derivative work of the SOFTWARE, and work produced by the SOFTWARE, as defined herein below.

By using, modifying or distributing the SOFTWARE, derivative work of the SOFTWARE, and work produced by the SOFTWARE under the terms of this License, Licensee indicates acceptance of this License, and agrees to be bound by all its terms and conditions.

1. DEFINITIONS.

- 1.1 The "SOFTWARE" is the CodeSynthesis XSD translator and the CodeSynthesis XSD runtime library (libxsd).
- 1.2 A "derivative work of the SOFTWARE" is any derivative work as defined in the copyright law of the nation or state where rights to the DERIVATIVE WORK OF THE SOFTWARE are exercisable; that is to say, a modification of the WORK PRODUCED BY THE SOFTWARE or CodeSynthesis XSD runtime library which has sufficient originality to qualify in such nation or state as a copyrightable work is a DERIVATIVE WORK OF THE SOFTWARE. For the purpose of this agreement and unless explicitly stated otherwise, the term DERIVATIVE WORK OF THE SOFTWARE shall exclude any derivative work of the CodeSynthesis XSD compiler itself.
- 1.3 A "work produced by the SOFTWARE" is source code that is generated by the CodeSynthesis XSD translator based on other works created by or for Licensee that Licensee provides to the CodeSynthesis XSD translator to produce such a work.
- 1.4 A "product" is a distribution unit identifiable by a unique name. A product contains a program, library, object code file and/or source code file or a collection of programs, program libraries, object code files, and/or source code files that can be standalone or forming part of a larger system.
- 1.5 To "distribute" means to broadcast, publish, transfer, post, upload, make available or otherwise disseminate in any medium to any third party.
- 1.6 "Physical source lines of code" is a measure of the generated source code as calculated by the CodeSynthesis XSD translator.

2. GRANT OF LICENSE.

Code Synthesis Tools CC hereby grants to Licensee a perpetual, non-exclusive, transferable right to distribute in source code, object code, or executable form works that are a derivative work of the SOFTWARE or a work produced by the SOFTWARE, provided that:

- a) such works are inseparable parts of a product created by Licensee and
- b) in any single distribution of this product the total number of physical source lines of generated code constituting the work produced by the SOFTWARE does not exceed 10,000 (ten thousand).

3. RESTRICTIONS.

Licensee acknowledges that the SOFTWARE is protected by copyright laws and international copyright treaties as well as other intellectual property laws and treaties. The SOFTWARE is licensed, not sold or given away for free. All title and copyrights in and to the SOFTWARE, including but not limited to any images and text incorporated into the SOFTWARE, the accompanying printed materials, and any copies of the SOFTWARE, are owned exclusively by Code Synthesis Tools CC.

Licensee may not sublicense, assign or transfer this License, the SOFTWARE, any derivative work of the SOFTWARE, or any work produced by the SOFTWARE except as permitted by this License.

4. LIMITED WARRANTY.

NO WARRANTIES.

CODE SYNTHESIS TOOLS CC EXPRESSLY DISCLAIMS ANY WARRANTY FOR THE SOFTWARE. THE SOFTWARE IS PROVIDED TO LICENSEE "AS IS," WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NONINFRINGEMENT OF THIRD PARTY RIGHTS. THE ENTIRE RISK AS TO THE USE, QUALITY AND PERFORMANCE OF THE SOFTWARE IS WITH LICENSEE. SHOULD THE SOFTWARE PROVE DEFECTIVE, LICENSEE ASSUMES THE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.
